ANNUAL MEETING NOTICE

The Board of Commissioners of the Bridgeport Downtown Special Services District (DSSD) hereby fix and call the Annual Meeting of Holders of Record Taxable Interests in Property in the DSSD. The meeting will be held on **Wednesday, May 14, 2025, at the Soundview Penthouse, located at 855 Main Street, Bridgeport, Connecticut 06604. The meeting will begin at 4:00 p.m.** All Holders of Record of Taxable Interest in Property in the Bridgeport DSSD are invited and required to attend. The meeting is open to the public, and all community members are welcomed and encouraged to attend.

The meeting is called for the election of members of the Board of Commissioners of the District and for the transaction of other business as outlined in the agenda for the meeting as follows:

ELECTION OF COMMISSIONERS

Under the Bylaws of the Bridgeport DSSD, the District is managed by a thirteen-member Board of Commissioners, nine of whom are property owners and four of whom are leaseholders, in addition to an ex-officio member who is the Mayor of Bridgeport. Each year, a slate of property owners and leaseholders are voted in for a three-year term on the Board of Commissioners.

At this initial meeting to elect leaseholders as Commissioners, two leaseholders shall be elected for a three-year term, one leaseholder shall be elected for a two-year term, and one leaseholder shall be elected for a one-year term. In future elections, all Commissioners irrespective of type shall be elected for three (3) year terms at the annual meeting of the membership in the year the term expires.

Who Votes: Only Holders of Record of Taxable Interest in Property within the District are eligible to vote. A list of the names and addresses of record holders within the District is accessible on our website: colorfulbridgeport.com/what-we-do under Our District and Services.

The percentage voting interests allocable to any taxable parcel consisting of a condominium form of ownership pursuant to the Connecticut Common Interest Ownership Act (Connecticut General Statutes





47-200 et. seq.) shall be subdivided on a per condominium unit basis by multiplying (a) the taxable parcel's voting interest prior to becoming a condominium by (b) the percentage that the condominium unit owner owns in the condominium's common elements as set forth in the applicable declaration of condominium. If a property is owned by a corporation, partnership, unincorporated association, or other form of entity, such entity may select an officer, partner, or agent to vote on its behalf.

The Ballot: At the coming election, three (3) property owner Commissioners and four (4) leaseholder Commissioners are to be elected. The property owner members of the Board whose terms are expiring include Commissioner Javier Ceja, Commissioner Jason Cohen, and Commissioner and Chair Philip Pires. For a complete list of the Bridgeport DSSD's current Board of Commissioners, visit colorfulbridgeport.com/who-we-are. **Enclosed in this mailing is a single ballot on which you may vote for both property owner and leaseholder candidates.**

Nominations: An online nomination form was open from March 5 to April 2, 2025, for all prospective property owner and leaseholder candidates to indicate their interest in serving on the Bridgeport DSSD Board of Commissioners. All prospective candidates were required to provide proof of ownership or their written lease within the DSSD service area. The ballot with the verified candidates is enclosed.

In addition to the slate of candidates on the enclosed ballot, an owner may nominate someone for a position on the Board of Commissioners by being present at the Annual Meeting and nominating your nominee at such time. In order for the floor nomination to be accepted, the candidate must provide proof of either property ownership or a written lease within the DSSD boundaries.

When to Vote: At the Annual Meeting, an election will be conducted. You may mail or email your ballot in advance of the meeting, vote in person at the meeting, or you may give your proxy to any third party to vote on your behalf for any nominee or any other matter that may come before the meeting.

It is very important that you attend the meeting since the Annual Meeting cannot occur without a quorum in person, by proxy, or ballots received in advance. The required quorum consists of a majority of the Holders of Record of Taxable Interest in Property within the District. Holders of Record of Taxable Interest in Property in the District are strongly encouraged to mail or email in their ballots ahead of the Annual Meeting.
